- i) To raise or collect funds by donation gifts, grant or endowment for the aforesaid objects.
- j) To merge or get merged in any trust having the main object similar to the objects of this trust.
- k) To do such acts, deeds and things as may be incidental or conducive to the furtherance of the above objects.
- l) The benefits of the Trust/institution shall be open to all irrespective of caste, colour, creed or religion.

5. Sh. Dev Raj is hereby nominated as Chairman of the Trust. Sh. Sanjay Dhand is nominated as Secretary, Sh. Surinder Pal Singh as Vice-Chairman and Smt. Usha Rani is nominated as Cashier of the Trust.

6. The Trustees shall hold the office for life until they resign or are removed from office.

7. Rules may be framed for the proper administration of the Trust, rules of the Trust at

any time be altered, modified or amended and be notified for information of the

persons connected with the affairs of the Trust. No amendment or alteration shall be

made which may prove to be repugnant to the provisions of section 2 (15), 11, 12 and

NOW THIS DEED WITNESSETH THAT FOR EFFECUATING THE TRUST

1. The name of the Trust shall be **Sat Sahib Educational Trust.**
2. The Trustees shall hold and stand possessed of the Trust property received for the Trust upon Trust to be used for such Public, Educational, Social & other purpose directly to the benefit of general public in any part of the Country.
3. The Head Office of the Trust will be situated at Dashmesh Nagar, Ahmedgarh or at any other place or places as the Trustees may decide from time to time.

4. The objectives of the Trust are as under:-

- a) To establish, open, run or manage schools or colleges where General, Scientific, Commercial, Engineering, Sports or any other type of Education be imparted to students.
- b) To organize or hold discourses and conferences on educational and sport subjects of moral uplifting.
- c) To establish, open, run or manage public libraries, reading rooms research centres, sports organization.

- d) To establish the maintenance of hostels, boarding houses for the students & staff and Dispensaries/Hospitalss.
- e) To elevate physical, mental and spiritual sufferings of the humanity by all





8. Trust may open its account in any bank, post office or in any other financial institutions. The Chairman and Secretary of the Trust shall operate the said bank accounts of the Trust jointly. The said accounts shall be maintained in the name of the Trust or in the name of institutions operated by the Trust.

9. Entire income of the Trust shall be utilized towards the promotion of aims and objectives of the Trust and shall be invested in the modes specified under the provisions of Section 13(1)(d) read with Section 11(5) of Income Tax Act 1961 and as amended from time to time.

10. The Trust shall maintain proper accounts of its income and expenditure. A Chartered Accountant shall duly audit the accounts. Every year the accounts shall be closed by 31st March.

11. The Board of Trustee shall have the power to acquire immovable or moveable properties for the Trust and likewise the power to sell, lease or mortgage or otherwise deal with such properties.

12. The Board of Trustee shall have power to borrow monies and also to mortgage the property of the Trust to fulfill the objects of the Trust.

13. The Board of Trustee shall meet as often as may be necessary or convenient to transact business and there should be at least one meeting in a quarter. The Board of Trustee might transact business and the decisions also by circulation of papers.

14. The benefits of the Trust shall be open to all irrespective of caste, creed, colour or

16. Without prejudice to the above provision any Trustee member who works whole time in the Trust may be paid such remuneration as may be fixed from time to time by Board of Trustee or reasonable and proper interest on money lent or rent on premises let to the Trust by any Trustee.

17. All decisions of the Trust shall be taken either unanimously or by Majority. There shall not be any casting vote to any member of the Trust.

18. The management and administration of the Trust shall vest in the Board and the Board of Trustee may delegate the powers to any member or to any other person for proper conduct or management of the affairs of Trust or any of its institutins.

19. The Board of Trustee have also power to appoint any member or members of Trust.

20. In the event of dissolutin of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among members of the managing committee/Trustee but same shall be transferred to the another Charitable Trust/Society whose objects are similar to those of this Trust and which enjoys recognition under Section 80-G of the Income Tax Act 1961 as amended from time to time.

21. The Trust formed shall be Irrevocable.

22. If any clause herein above contained, contravenes any of the provision of the Income Tax Act or Rules or amendments made therein from time to time, granting exemption of the Income/Registration, then such clause(s) shall be deemed to be redundant from the date of its contravention.
