2. Teaching of Punjabi upto 10th Standard is compulsory in the school and CBSE New Delhi will conduct Punjabi Language Examination. In case of failure to comply to this, NOC will be withdrawn immediately.
3. After the CBSE, New Delhi Affiliation, the management will pay salary and other allowances as per the Govt. Scale to its Teaching and Non-Teaching staff. In case of failure, NOC will be withdrawn.
4. You and your management will also ensure that any information asked by your District Education Officer or Senior Officer of Education Department will be provided and every possible help will be rendered to these authorities.
